John qualified as a solicitor at the prestigious London firm Farrer & Co in 1990 and moved to Devon in 1994. He trained as a family mediator in 1997 and as a civil/commercial mediator in 2003. In order to concentrate fulltime on his mediation career, John set up Mediation First (formerly South West Mediation) in 2003 which is now one of the largest mediation providers in the country. John was personally recognised with the Leader of the Year Award at the 2019 Devon and Somerset Law Society Awards while South West Mediation also won the Team of the Year Award and was Highly Commended in the Law Firm of the Year category.
